# MINUTES:

Mr. Sarno stated that he voted no regarding the adoption of Ordinance No. 6-2022.

The Secretary stated that he did hear his "no" vote.

The Minutes of the July 5, 2022 meeting were approved by motion of Mr. Holmes, second by Mrs. Kesslelr. Motion carried.

## VISITORS:

A motion was made by Mr. Holmes, second by Ms. Clayton, to hear from visitors at this time. Motion carried.

Emily Palmsano, 416 Emerson Street, stated that she received a letter from the Code Officer regarding dog waste. She stated can't understand why she got this letter when the Code Officer never responded to her complaint regarding the property at 414 Emerson Street.

Don Detar, 213 Lowell Street, addressed Council in regards a need to resolve the skunk problem in his area. He also stated that something needs to be done regarding people putting their garbage days prior to pickup. Also, he stated that there is a rooster at-large in the neighborhood.

Jim Williams, 126 Oregon Avenue, also addressed the need to stop people from putting out their garbage, in bags, prior to pickup. He stated that the police need to enforce this matter and start issuing tickets while they patrol town.

Tammy Domiano, 109 Lowell Street, again addressed the issue with her neigbor's tree hanging over on to her property, of which, caused her husband to incur an injury from the wet leaves on her sidewalk. She stated that nothing to date has been done to correct this problem and that she will take whateve action is needed to resolve this matter.

Mrs. Domiano stated that the trees in the Borough can be classified as vegetation, the same as grass, etc., of which can be enforced by the Borough. (See pages 2-A & 2-B)

Solicitor Loperfito stated that he is not familiar with this matter, and will take this under advisement.

Tim Gourley, 159 Grant Avenue, requested permission to close Grant Avenue, from Columbia Avenue to Sumner Avenue, on October 15, 2022 for the "Witching Hours Night Market". (See page 2-C).

Karene West, 400  $4^{th}$  Avenue, New Kensington, commended the Borough for a successful Art Festival Event.

Christine Sallade, 116 West Adams, stated that the vacant property at 114 West Adams is overgrown with high grass and shrubs. She also stated that she called 911 to have the police come to Davis Field regarding kids running all through the stadium area. She stated that the police never showed up.

Debbie Pugliese,  $505 \frac{1}{2}$  Linden Street, complained about the property located at 411 Linden Street. She stated that it is also overgrown with grass and weeds.

John Michelle, 328 Walnut Street, requesting something to be done about tractor trailors coming up Linden Street to delivery product to Donghia Lumber and causing damage to his property in an attempt to make the turn on to Walnut Street. He stated that the newly erected signs to prevent them coming up Linden are not helping.

Mr. Holmes stated that he requested Representative Jason Silvis to contact PennDot to make adjustments to the GPS system to correct this problem.

# Vandergrift Borough Code 356-2

Grass, weeds, and certain other vegetation prohibited nuisance under certain conditions. No person owning or occupying any property within Vandergrift Borough shall permit grass/weeds or any vegetation whatsoever not edible or planted for a useful or ornamental purpose to grow or remain upon such premises so as to exceed a height of 6" or to throw of any unpleasant or noxious odor or to conceal any filthy deposit or to create or produce pollen. Any grass, weeds or other vegetation growing upon any premise in the Borough in violation of this section is hereby declared to be a nuisance and detrimental to the health safety and cleanliness and comfort of the inhabitants of the Borough.

Definition of vegetation - Trees, shrubs, nursery stock and other vegetation and includes limbs or growth of any vegetation.

These trees are over 30 feet high, they are not maintained only one time by order of the magistrate many years ago. They do not have an ornamental purpose and they are over 6" of height. They are causing health safety to my property by their debris clogging the gutter and downspout which is illegal runoff on my property. Christine, Mr. Bove, and Brian are aware of this situation as they were at my house several times. Brian and my husband Rich determined what the problem was. It has not been resolved.

The State says a landowner is held to a duty of common reasonable prudence in maintaining shrubs, trees on their own property so as to prevent injury to others or to property of another.

This is intentional or reckless, negligent reckless or in the course of an abnormally dangerous activity when there are legal remedies.

# Vandergrift Borough Code 356-4

Authority for the Borough to remove trim or cut at the expense of owner of occupant. The Borough Council or any officer or employee of the Borough designated thereby for the purpose is hereby authorized to give notice by personal service or by US Mail to the owner/occupant as the case may be of any premises where on grass, weeds, or other vegetation is growing or remaining in violation of the provision of 356-2 of this article directing and requiring such owner or occupant to remove, trim, or cut such grass, weeds or other vegetation so as to conform to the requirements of this article within 5 days after issuance of such notice. In case any owner or occupant shall neglect, fail, or refuse to comply with such notice within a period of time stated thereon, borough authorities may remove, trim, or cut such grass or other vegetation and the cost of such work with an additional amount of 10% may be collected by the borough from such owner or occupant in the manner provided by law.

In 1975, Pa, Superior Court declared that the owner of land in or adjacent to a developed or residential area is liable for damage caused by a tree on their property if they knew or should have known that a defect in the tree posed an unreasonable danger to persons or property outside their land and the damage occurred as a result of their failure to remedy the dangerous defect. The court articulated a two-part duty of reasonable care on the property owners to learn of defective condition in their trees and 2 remedy the condition by treating or removing the tree or otherwise acting to remedy the danger posed by the condition Pa Courts have held that this require owners to visually inspect the tree. Owners may have to take additional steps to learn of any defective conditions. The duty to address a defect entails whatever is sufficient under the circumstance to address the danger posed by the defect. In practice property owners should periodically perform visual inspections of trees on their property large enough to cause damage to other properties. In addition common law duty described, Pennsylvania property owners may face municipal regulation concerning the cutting or removal of trees. For example all First class townships and Second class townships have the express authority to require property owners to trim or remove trees diseased or otherwise if the trees could obstruct use of public roads or public property or otherwise effect public health, safety, or welfare.'

Contact your city, most cities have rules regarding objects on someones property that could be deemed dangerous. A tree that extends over your home and yard could be considered a hazard and you have a right to report it to your city. The city could make your neighbor pay a fine if they fail to remove the tree.

Tresspass theory – seek equitable relief compeling the trespassing neighbor to remove the trees to the extent of the encroachment and seek approprate incidental and consequential damages.

To the Vandergrift Borough Council:

We are requesting permission to use Grant Avenue on October 15, 2022 for The Witching Hours Night Market. The market is being organized by local business owners Shannon Gourley (Honey and Heart Candle Co.), Lisa Brunermer (Full Circle Furniture and Gifts, and Aleesha Kelly (Convergence Studios) with guidance from members of the VIP and an organization committee of over 20 residents.

The market will run from 5-9pm with a setup time of 3pm. There will be vendors and food trucks in the street as well as in the Vandergrift Market building. This a Halloween themed event with vendors all falling into this category. We are requesting permission to close the street from where Grant meets Columbia to Sumner.

We will obtain all necessary insurance required for the event and provide a copy of the insurance to the borough upon preliminary council approval.

There is a lot of interest in this event which will benefit the town and the small businesses in the town. Proceeds from the event are going to a fund to purchase commercial grade string lights for the business district.

Westmoreland County is now accepting applications for the 2023 Community Development Block Grant (CDBG) Program. Any municipality or agency that plans to submit a project for 2023 CDBG funding consideration must submit an application to this office by <u>September 30, 2022</u>. The 2023 program year begins May 1, 2023, however all projects must first be evaluated and inspected by CD staff, approved by the Westmoreland County Commissioners and submitted to the U.S. Department of Housing and Urban Development for final approval. <u>Therefore, it is essential that the application is submitted to us no later than September 30, 2022.</u>

Prior to submittal, please review the application carefully to ensure that all requested information is included. Incomplete applications will not be considered. If a project was previously submitted and not chosen for funding, a new application must be submitted that contains updated cost estimates, maps, etc. to be considered for 2023 funding. Furthermore, please be aware that HUD has released new low and moderate income survey data based on the American Community Survey 2011-2015 (ACS). A map of all census tracts/block groups is available at <a href="https://bit.ly/2RGTeEb">https://bit.ly/2RGTeEb</a>. Please review your census tract data carefully, as it may have changed from the last 5-year ACS estimate.

Mrs. Wilson informed Council that Jade Bothell, a part-time labor, has quit.

## **ENGINEER'S REPORT:**

Chelsea Walker, Westmoreland County Conservation District, addressed Counil in regards to executing an agreement between the Borough, PennDot and the Westmoreland Conservation District relative to the mitigation project at the Columbia Avenue. She state that the project include in providing a few rain gardens, pervious paving and the paving of most of the parking lot.

- b. A motion was made by Mr. Holmes, second by Mr. Uskuraitis, to approve final payment of \$31,641.29 to Fuller Building Group. Motion carried.

Engineer Bove stated that the 2022 Street Paving Project using Liquid Fuel Funds regarding First Street and Oak Street has been accepted by the low bidder, West Penn Paving, LLC, in the amount of \$26,905.00.

A motion was made by Mrs. Wilson, second by Mr. Holmes, to award the aforementioned street project to West Penn Paving, LLC, the low bidder at \$26,905.00 using Liquid Fuel Funds. Motion carried.

Engineer Bove stated that the Borough has received the first payment regarding the Timber Sale Agreement.

Engineer Bove informed Council that he has contacted PennDot to fix Sherman Avenue and Longfellow Extention.

Engineer Bove stated that he will need a lists of streets to include in the 2023 application for DCBG funds.

Engineer Bove stated that he sent a letter to DEP regarding a septic complaint at 809 LaBelle Vue Road.

Engineer Bove stated that Spaniel Beer Distributor desires to erect a ramp out in from of their building.

In regards to the structures at 122 Franklin Avenue and 1013 Poe Street, a motion was made by Mr. Holmes, second by Mr. Uskuraitis, to authorize the Borough Enginner to move forward with obtaining a right of entry to these properties and to seek funding from the County. Motion carried.
