

- 4. <u>Demo-Fund Applications</u> Prepared and Submitted 3 Applications to the County for 122 Franklin, 411 Linden and 1013 Poe
- 5. <u>Condemnation Order</u> As requested prepared the order required for 303 Lowell Street Unsafe, Vacant Structure
- 6. <u>Driveway Permits</u> 3 permits are pending for 131 East Adams, 408 Jackson and 500 Lowell. They need to make the applications and pay the fees. 131 East Adams does not meet the required sight distance left due to parked cars on adjacent property.
- 7. <u>Columbia Avenue Parking Lot SWM Project</u> necessary agreement amendment initialed. The agreement should be approved by PennDOT soon.
- 8. <u>Project 70 Timber Harvest</u> Herbicide application completed. Dave O'Barto to let us know ahead of time as to the start date for timbering.
- 9. <u>Vandergrift Pool</u> Liner top disconnection problems measured, located, photographed and documented. Will follow up with Renosys to see if they can determine the cause and help us with the resolution.
- 10. <u>Olmsted Commons</u> Will soon have plans and spec.s ready to submit to DSCNR for approval to advertise and bid.
- 11. <u>109 and 110 Washington Demolitions</u> Contractor selection moving forward for these County demolitions.

Solicitor Loperfito presented a Full and Final Release Agreement between the Borough of Vandergrift and West Penn Paving LLC, in which West Penn Paving agrees to release the Borough in regards to the Street Paving and Patching Project using Liquid Fuel Funds. (See pages 5-A & 5-B)

A motion was made by Mr. Holmes, second by Mrs. Wilson, to execute the aforementioned agreement. Motion carried.

#### **FULL AND FINAL RELEASE**

THIS AGREEMENT, is made by and between the Borough of Vandergrift, a municipal corporation with a principal office of 109 Grant Avenue, Vandergrift, Westmoreland County, Pennsylvania 15690 (hereinafter referred to as "Owner") and West Penn Paving, LLC, a Pennsylvania Limited Liability Company with a principal address of 4311 Sardis Road, Pittsburgh, Allegheny County, Pennsylvania 15239 (hereinafter referred to as "West Penn or Releasor") when Owner and West Penn/Releasor are discussed together, they may be identified as "The Parties."

WHEREAS, on September 6, 2022, Owner and West Penn entered into an agreement for West Penn to furnish all materials and do all work required for the 2022 street paving and patching project in the Borough of Vandergrift using liquid fuels funds subject to the plans and specifications in accordance with PennDOT's specifications publication 408 (as amended);

WHEREAS, the executed agreement followed the presentation of a bid proposal from West Penn said proposal having been dated July 4, 2022, and represented work on First Street, Florida Avenue, Virginia Avenue, Michigan Avenue, and Oak Street within the Borough of Vandergrift;

WHEREAS, bids were opened on July 6, 2022, and as a result thereof, the Borough of Vandergrift chose to eliminate all work on the paving project except for First Street and Oak Street, which reduced the bid by fifteen percent (15%) the same having been awarded by the Council of the Borough of Vandergrift on August 1, 2022 at the lower financial level;

WHEREAS, said bid documents were referred to and reviewed by Richard Skovensky, Jr., Municipal Services Supervisor of the Pennsylvania Department of Transportation, who objected to the awarding of the bid on the basis that the same was violative of the Governors Center for local government services (DCED) purchasing handbook; determining that the same amounted to a bid negotiation and denied project approval;

WHEREAS, the Owner and West Penn/Releasor, have agreed that Releasor, intends to release Owner from any and all obligation, liability, or damages or any type, kind, or sort, as associated with the contract and agrees to release the contract, in full, voiding the same with no responsibility, to either party, nor cost, fee, or expense, to either party, under the terms and conditions as set forth in this full release of all claims;

NOW THEREFORE, the parties do hereby enter into this mutual release, under and pursuant to the following terms:

- 1. The provisions set forth in the "Whereas" provisions above are substantive in nature and the parties, and each of them, agree that the terms set forth above, shall be deemed material terms to this full and final mutual release;
- 2. West Penn/Releasor agrees, to release and forever discharge Owner from any and all actions, causes of action, applications, debts, dues, accounts, bonds, covenants, contracts, complaints, obligations, duties, breaches of contract, breaches of duty of any relationship, acts, omissions, compensation, promises, damages, costs, fees, loses, including any losses associated with lost opportunity, as well as any other loses or claims of any type, kind, or sort as related to the bid and contract referenced in this agreement, now and forever.

- 3. Owner does hereby agrees, to release and forever discharge West Penn from any and all actions, causes of action, applications, debts, dues, accounts, bonds, covenants, contracts, complaints, obligations, duties, breaches of contract, breaches of duty of any relationship, acts, omissions, compensation, promises, damages, costs, fees, losses, as well as any other loses or claims of any type, kind, or sort as related to the bid and contract referenced herein, now and forever.
- 4. The parties, and each of them, fully agree that there is good and substantial consideration for the release agreement and, do hereby waive any claims for insufficiency of consideration now or at any time in the future.
- 5. The parties, and each of them, acknowledge that this is a full and final release and that West Penn/Releasor and Owner both intend and expressly agree that this release shall be effective as a bar to each and every claim, demanding cause of action, that the claiming party has or may have against the other party now or at any time in the future relating to the contract herein identified.

IN WITNESS WHEREOF, and intending to be legally bound hereby, the parties do hereby set their hands and seals as of the date corresponding to their signature below.

He also stated that once ATI completes their construction projects the County will perform a reassessment, of which may be equal or greater than the current assessment.

A motion was made by Mr. Holmes, second by Mr. Sarno, to approve the aforementioned settlement. Motion carried.

Please be advised that if you wish to continue operating your over-posted-weight vehicle on Arizona Avenue, you will need to apply for a permit to operate the vehicle on Arizona Avenue from the Vandergrift Borough Offices. Please keep in mind that if granted, the same is associated with various requirements, including but not limited to, bonding. Please be advised that until you obtain a permit to operate the over-posted-weight vehicle, that on or after November 13, 2022, any operation of the over-posted-weight vehicle on Arizona Avenue will be subject to the fines and penalties contained within Vandergrift Borough Code Section 470-73.

#### **RESOLUTION 9 OF 2022**

RESOLUTION OF THE BOROUGH OF VANDERGRIFT, COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA TO IMPLEMENT ACT 57 OF 2022 - PROPERTY TAX PENALTY WAIVER PROVISIONS

**A RESOLUTION** of the Council of the Borough of Vandergrift, County of Westmoreland to implement Act 57 of 2022.

**WHEREAS**, Act 57 of 2022, amending the Local Tax Collection Law, was signed by Governor Wolf on July 11, 2022, and takes effect on October 10, 2022; and

WHEREAS, Act 57 requires taxing districts that impose taxes on the assessed value of real property to adopt a resolution or ordinance within 90 days of the effective date of the act, or not later than January 9, 2023, directing the tax collector to waive additional charges for real estate taxes in certain situations; and

**NOW THEREFORE, BE IT RESOLVED**, that the Tax Collector of the Borough of Vandergrift shall comply with the provisions of Act 57 and this resolution for tax years beginning on or after January 1, 2023.

#### **DEFINITIONS**

The following words and phrases shall have the meanings given to them within this resolution unless the context clearly indicates otherwise:

Additional charge: Any interest, fee, penalty, or charge accruing to and in excess of the face amount of the real estate tax as provided in the real estate tax notice.

# Qualifying event:

- 1. For the purposes of real property, the date of transfer of ownership.
- 2. For manufactured or mobile homes, the date of transfer of ownership or the date a lease agreement commences for the original location or relocation of a manufactured or mobile home on a parcel of land not owned by the owner of the manufactured or mobile home. The term does not include the renewal of a lease for the same location.

Tax Collector: The elected tax collector for the Borough of Vandergrift, Westmoreland County, any authorized or designated delinquent tax collector, the Westmoreland County Tax Claim Bureau, or any alternative collector of taxes as provided for in the act of July 7, 1947 (P.L.1368, No.542), known as the "Real Estate Tax Sale Law," an employee, agent or assignee authorized to collect the tax, a purchaser of claim for the tax or any other person authorized by law or contract to secure collection of, or take any action at law or in equity against the person or property of the taxpayer for the real estate tax or amounts, liens or claims derived from the real estate tax.

#### WAIVER

The Tax Collector shall, for tax years beginning on and after January 1, 2023, grant a request to waive additional charges for real estate taxes if the taxpayer does all of the following:

- A. Provides a waiver request of additional charges, on a form provided by the state Department of Community and Economic Development, to the Tax Collector in possession of the claim within twelve (12) months of a qualifying event;
- B. Attests that a tax notice was not received; and
- C. Provides the Tax Collector in possession of the claim with one of the following:
  - 1. A copy of the deed showing the date of real property transfer; or
  - 2. A copy of the title following the acquisition of a mobile or manufactured home subject to taxation as real estate showing the date of issuance or a copy of an executed lease agreement between the owner of a mobile or manufactured home and the owner of a parcel of land on which the mobile or manufactured home will be situated showing the date the lease commences; and,
- D. Pays the face value amount of the tax notice for the real estate tax with the waiver request.

At this time President Chvala stated that the purpose of this recessed meeting of November 7<sup>th</sup>, is for the purpose of presenting the proposed budget of the Borough of Vandergrift for the fiscal year, 2023. She stated that following the presentation of the propose 2023 Budget Council, if approved, can move to advertise the proposed budget for public inspection until December 5, 2022 until 3:30 pm, Monday, December 5, 2022.

At this time the Secretary presented and reviewed, in detail, the contents of the proposed General Fund Budget, the Vandergrift Park & Pool Budget, and the Special State Aid Budget for 2023.

The Secretary stated that the tax rate for 2023 will remain at 28 mill. However, he stated that the Budget Committee is recommending the following changes in Refuse and Sewer Recovery Fees:

- 1. Reducing the Sewer Recovery Fee from \$45.00 per quarter to \$42.00 per quarter for the Year 2023.
- 2. Increase the Refuse Collection Fee from \$81.00 per quarter to \$87.00 per quarter for the

Year 2023.

The Secetary stated that the aforementioned changes to to refuse and sewer fees will enacted by resolution at the December 5, 2022 meeting.

Following a lengthy discussion regarding to aforementioned fees, a motion was made by Mr. Holmes, second by Mrs. Kessler, to advertise the 2023 Budget of the Vandergrift Borough for public inspection until 3:30 pm., Monday, December 5, 2023, to be adopted at the December 5, 2022 meeting of the Vandergrift Council. Motion carried.
