MINUTES:

The Minutes of the May 1, 2023 meeting were approved by motion of Mrs. Wilson , second by Ms. Clayton. Motion carried.

VISITORS:

A motion was made by Mr. Uskuraitis, second by Ms. Clayton, to hear from visitors at this time. Motion carried.

Linda Ringle, 121 Virginia Avenue, addressed Council in regards the damage being done to Arizona Avenue by a resident who continues to traverse this street with his large truck. She also stated that the resident allows his dog to do its business in adjourning yards.

Chief Caporali stated that this person was cited and was found not guilty at the magistrate's office. He also stated that the Borough Solicitor is recommending to refile a another citation.

Don Detar, 213 Lowell Street, addressed Council in regards to a vehicle parking on the curb at the end of Beech Street.

Chief Caporali requested that Mr. Detar call 911 when he observes this matter.

Katy Vance, 130 California Avenue, addressed Council in regards to a drainage problem effecting the property of Michele Stefanik at 141 California Avenue.

Mrs. Wilson stated that she will be discussing this drainage problem under her report.

Jessie Vance, 130 California Avenue, thanked the police for their response to 135 California Avenue and questioned what is being done to the owner.

Chief Caporali requested that Mr. Vance provide his phone number and that he would look into this matter.

Jim Williams, 126 Oregon Avenue, recommended that Mrs.Wilson contact PennDot to post road closed signs on LaBellvue Road. He also stated that vehicles are speeding on Pennslvania and Delware Avenues due to the closing of part of LaBellvue Road.

Mr. Williams questioned why Carl Petrarca's son, at Pennsylvania Avenue, is permitted to repair and sell quads, and is this a business activity. He also stated that the trash at the Petrarca's residence is blowing around the area due the trash lids not being placed correctly.

Mr. Williams questioned why the police have not cited the vehicle on the 200 block of Grant for being out of inspection. He also stated that a state trouper issued numerous violations regarding this matter.

A motion was made by Mr. Uskuraitis, second by Mr. Clayton, to return to the regular order of business. Motion carried.

The Secretary stated that an anonymous letter was received, but will not be read due to the Borough does not acknowledge any anonymous correspondence.

Dear Vandergrift Borough Council,

We're writing you for your consideration to put a permanent fix in place for the borough road water drainage issue at the end of California Avenue.

The last time the street was paved, a basin was not installed at the end of the street. Instead the road was raised to push the water 200 feet up the street into a basin. We questioned the plan at that time and were told this was the proper solution for drainage. This solution did not last more than a couple of years as the road sank.

Over the years, we've spent countless hours and our own money to dig French drains around our two properties to divert borough street water. We even have double French drains in place. Our two properties have taken on water on several occasions because the borough never put a permanent solution in place to collect the road water. Our neighbors have also taken on water because the road sunk on the sides causing the water to rise above the curbs into properties instead of into the basins.

We're thankful that the borough did work with us last year to put our small temporary drains in to catch and divert the road water until a permanent solution was put in place by the borough. These small drains cannot handle water from heavy rains and nor can they handle the weight of trucks that turn around at the end of the street. Now that the road is slated to be paved the borough needs to put a permanent plan in place to control the street water. This should not continue to be a taxpayers concern.

A basin needs to be properly installed by the borough to contain the street water. Simply raising the road again for it to sink one more time isn't the solution for the taxpayers in the community. Oregon Avenue has a great containment system in place and we'd like to see the borough take the same type of approach at the end of our street. California Avenue needs curbs all the way around including the end of the street for the water to be diverted into a borough drain or culvert.

If needed, we are more than willing to grant a right of way near our property line for a culvert to be placed at the end of the street to move the water over the hill rather than onto our property and into our homes.

Hopefully you will approve using dollars from the sewage recovery fund to put a permanent solution in place. It will cost the borough less money to fix this issue now than it will later in time.

We're also requesting that a FULL sized no outlet sign be placed at the top of the street.

STREET & SANITATION REPORT:

Chairperson Wilson reported that the repairs to the backhoe will cost approximately \$18,000. She stated that some planned work will need to wait until the backhoe is fixed.

Mrs. Wilson reported that she has begun painting parking marking spaces on Holland Street, Franklin Avenue and part of Sherman Avenue. She also stated that the Department will start painted crosswalks.

Mrs. Wilson reported that the Department has been trimming low hanging tree limbs on various streets.

Due to a drainage problem in the rear of the YMCA on Pennsylvania, Mrs. Wilson stated that she intends to correct the problem with installation of a small 2×2 catch basin at a cost of \$396.00, work to be done in-house.

In regards to letter received from Michele Stefanik, Mrs. Wilson recommended that this situation be resolved with installation of a trench boxes, work to be done in house.

A motion was made by Mrs. Wilson, second by Mrs. Kessler, to approve work on the aforementioned matter to be funded with sewer recovery funds. Motion carried.

A motion was made by Ms. Clayton, second by Mrs.Kessler, to accept the Street & Sanitation Report. Motion carried

ENGINEER'S REPORT:

Engineer Bove stated that he will be holding a preconstruction meeting with the contractor awarded the bid on the 2023 Paving & Patching Liqid Fuels Project.

Engineer Bove reported on the on going work at the Vandergrift Pool. He stated that the contactor, KGD, started work on May 25th and has 30 days to complete the work. He also stated that the pool liner company, Renosys, has acknowledge that they will be in on June 26th to re-attach the liner. He anticipated the opening of pool by the first of week of July.

Engineer Bove stated that a hearing will be held on June 1st regarding an unsafe structures at 704/706 Holland Street.

Engineer Bove reported that the Columbia Parking Lot Stormwater Mitigation Project agreement has been signed and that a go ahead from PennDot to proceed. He also stated that he working with the Westmoreland Conservation District on the design for a DEP permit.

Engineer Bove questioned whether Council is willing to participate in a County Water & Sewer Grant with a 25% match.

Mr. Holmes stated that Council would only be interested if there was no match requirement by the Borough

Engineer Bove stated that he is awaiting for the grant contract from DCED regarding the Casino & Library Building Project.

Engineer Bove questioned whether Council would like him to file for a waiver regarding the MS4 Storm Water Management Act. He explained that the previous waiver has expired.

A motion was made by Mr. Uskuraitis, secondby Mrs. Kessler, to authorize the Engineer to apply for another waiver regarding the aforementioned matter. Motion carried.

Engineer Bove reported that he is working on a DCED Multimodal Grant Application. He stated that he will need a commitment letter from the Borough and a copy of the 2022 Financial Audit of the Borough.

Engineer Bove reported that the Project 70 Tree Harvest as been completed.

A motion was made by Mrs. Wilson, second by Mr. Uskuraitis, to accept the Engineer's Report. Motion carried.

BUDGET & FINANCE REPORT:

Chairperson Clayton stated that each member of Council has received copies of the General Fund, Pool Fund, and State Aid Fund budgets.

A motion was made by Mrs. Wilson, second by Mr. Uskuraitis, to accept the Budget & Finance Report. Motion carried.

POLICE & PUBLIC SAFETY REPORT:

Chairperson Holmes provided an update on the parking meters in town. He stated that of the over 200 meters tested, those that failed were result of giving too much time. Therefore, the customers were not being cheated. He also stated that only 1 failed due to a mechanic problem.

Mr. Holmes stated that he would like to extend a conditional offer of employment, to a parttime police officer, to Joel Aston. He stated that this offer is contingent upon him successfully attaining certification through the Pennsyvania Municipal Police Officers Training and Education Commission, along with a satisfactory background check and a personal interview.

A motion was made by Mr. Holmes, second by Mrs. Wilson, to approve the aforemention matter. Motion carried.

Chief Caporali provided the following activity report for the month of May:
