The secretary reported that the Code Officer issued 40 notice violations, issued 3 citations, and attended 1 court hearing in September.


A motion was made by Mr. Sarno, second by Ms. Clayton, to accept the Code Officer's Report. Motion carried.

Ladies and Gentlemen,

The following are my requested agenda items for the Tuesday, October 7, 2024 Council meeting:

- 1. <u>Grant Avenue & McKinley Street Reconstruction</u> (CEAP Grant) Preconstruction meeting held 9-25-2024. Preconstruction minutes, agreements, required forms and documents submitted. Work to be completed either before 10-11 or after 10-14 due to the scheduled event on Grant Avenue.
- Olmsted Commons Park Development Project Contractor moving in this week. The car and millings need to be removed. We have 3 Options according to our new DCNR Project Manager, one of which will need to be selected. See Olmsted correspondence forthcoming.
- 3. Casino Theater & Library Building Improvement Project Phase 2 ADA Parking spaces are not be feasible on the site as they would take up the entire area to meet ADA required slopes for the pad and access ramps and other parking spaces will be lost. Discussion with the CTRM indicate that their current drop-off method to accommodate ADA patrons and entertainers works well. For this reason, and also due to the reduced award amount from DCED, we are planning to omit the ADA parking. I am planning to meet with the Librarian regarding the plaster work which will be included along with the pointing, sealing and window replacements.
- 4. <u>Ninth Street Retaining Wall Replacement Project</u> (CEAP Grant) Site meeting to be scheduled with the Geotechnical Engineers to obtain cost and tech. proposals.
- 5. <u>Columbia Ave. Parking Lot Rain, Gardens & Tree Pits</u> The WCD tentative schedule for the project to be advertised for bids is fall 2024 or winter. A PennDOT HOP still may be required to access the MH on Sherman which may affect the schedule.
- 6. <u>Subdivision Plan</u> No update for the California Avenue Plan and the Legal documentation required for the Quiet Title.
- 7. <u>411/413 Linden</u> (former Moose Lodge) Proposed Parking Lot, Driveways & Stormwater Management Plan. No update (Anticipate a ZHB Hearing Application).
- 8. <u>2024 CDBG Project</u> County Planning has authorized advertising. Therefore, in order to avoid added costs and multiple bid addenda for constantly changing Davis Bacon Wage Rates, we need to know from Council the Bid Opening date and anticipated Completion Date for the work (i.e. Fall 2024 or spring 2025).
- 9. <u>2025 CDBG Application</u> Submitted. Copy of submitted application will be presented during the meeting.
- 10. <u>MS4 Waiver Application</u> Authorization for signatures, \$500 fee to Commonwealth of Pennsylvania and confirmation that the **NOI Contact names and numbers** are the same as those submitted for original waiver. (If possible, please have the check available at the meeting).
- 11. <u>DCED LSA Category 4 Grant Application</u> Submitted. Copy of submitted application will be presented during the meeting.
- 12. <u>219 225 Grant Avenue Partial Building Collapse</u> Progress slowly being made. 11<sup>th</sup> Street is open. Several items have yet to be accomplished.

#### 13. PNG Gas Line Replacement Projects

- a. Franklin Avenue Project On hold.
- b. Sherman Avenue Project Phase 2 (Sherman, 6 St. and 11<sup>th</sup> St.) Near Complete.
- c. Washington Avenue Project (Hancock, Custer, 16<sup>th</sup>, 15<sup>th</sup> and Washington) Complete.
- d. Fourth Street Project -Complete.
- e. Sherman Avenue Project Phase 1 Near complete.
- f. Columbia Avenue Leak Project (11<sup>th</sup> Street) According to PNG the revised start date is planned for November 29, 2024.
- g. Grant Ave. & McKinley Crossings Project Complete.
- h. Longfellow Street Project Planned for August 20, 2025 (Note this street is to be paved under the 2024 CDBG project).
- i. LaBelle Vue Project Under design. Please advise of any concerns or issues regarding the plans submitted. Anticipate an application being filed soon.

- 14. MAAT Agreement for LaBelle Vue Road Sewer Connection No update

#### **BUDGET & FINANCE REPORT:**

Chairperson Clayton stated that copies of the General Fund, Park & Pool Fund, and the State Aid budgets have been provided to members of Council.

With a balance of \$4,600.80 balance in the Park & Pool Fund, the Secretary requested that Council approve a transfer of \$6,000 from the Timber Fund to the Park & Pool Fund to cover forthcoming invoices.

A motion was made by Mr. Sarno, secod by Mr. Young, to approve the aforementioned request. Motion carried.

#### **POLICE & PUBLIC SAFETY REPORT:**

A motion was made by Mrs. Kessler, second by Mr. Sarno, to hire Peter Forestieri as an extra police officer serving ona part-time basis for the Borough of Vandergrift from time to time on an hourly or daily basis as needed. Motion carried.

Chairperson Kessler stated that Diane Grainy, 268 Sherman Avenue, has applied for a Persons With Disability Parking Place and has met all the eligibility requirements.

A motion was made by Mrs. Kessler, second by Mr. Sarno, to approve the aforementioned matter. Motion carred.

### **BUILDING & GROUNDS REPORT:**

Chairperson Sarno requested an update on the delinquent refuse/sewer recovery letters. He stated that about 170 delinquent notices were sent and to have collected \$16,000.

He stated that the Borough Engineer has provided an update on the Olmsted Commons Project.

A motion was made by Mrs. Wilson, second by Mrs. Kessler, to accept the Building & Grounds Report. Motion carried.

#### TREE & LIGHTS REPORT:

Chairperson Bruner reported that no street lights were reported out and there were some trees trimmed by the Borough Crew.

A motion was made by Mrs. Wilson, second by Ms. Clayton, to accept the Tree & Light Report. Motion carried.

#### **GENERAL GOVERNMENT REPORT:**

President Holmes stated the Vandergrift Civil Service needs to be activated for the purpose of hiring a full-time police officer.

A motion was made by Mrs. Wilson, second by Mr. Sarno, to notify the Vandergrift Civil Service Commission to prepare and provide list of eligibility candidates for the position of full-time police to the Vandegrift Council.

A motion was made by Mr. Sarno, second by Ms. Clayton, to accept the General Government Report. Motion carried.

### **RECREATION REPORT:**

Chairperson Young informed Council that the Borough has received a grant to provide a "Pickle Ball Court" at Kennedy Park.

Mr. Young reported that he has obtained materials for repairing the fence along Kennedy Park.

Mr. Young stated that pool has been winterized for the season and that a dead tree needs to be removed.

A motion was made by Mr. Sarno, second by Ms. Bruner, to accept the Recreation Report. Motion carried.

Mrs. Kessler reported that a location has been found for the installation of the Vandergrift Gateway Monument. She stated that the monument will be located at the Vandergrift end of the Vandergrift Bridge.

Ms. Clayton stated that a "Bike Bus" event will be held for children in Third & Fourth Grades who ride their bikes to school.
