TAX ORDINANCE 5 OF 2023

AN ORDINANCE OF THE BOROUGH OF VANDERGRIFT, COUNTY OF WESTMORELAND, AND COMMONWEALTH OF PENNSYLVANIA FIXING THE TAX RATE FOR FISCAL YEAR 2024.

BE IT ORDAINED AND ENACTED, and is hereby ordained and enacted by the Council of the Borough of Vandergrift, County of Westmoreland and Commonwealth of Pennsylvania:

Section 1. That a tax be, and the same is, hereby levied on all property and occupations within the said Borough subject to taxation for Borough purposes for the year 2024 as follows:

Tax rate for general Borough purposes, the sum of twenty-eight (28) mills remains on each dollar assessed valuation.

Making a total tax rate for all Borough purposes of twenty-eight (28) mills remains on each dollar of assessed valuation.

Section 2. That any ordinance, or any part of any ordinance, conflicting with this ordinance shall be hereby repealed insofar as the same affects this ordinance.

- 8. Rebuilt block wall around the drainage pipe behind pump building at the Pool.
- 9. Freightliner garbage ruck was hit by Westmoreland Transit Authority Bus.
- 10. Collected leaves on various streets.

ENGINEER'S REPORT:

In regards to the application for the 2024 CDBG Street Application, Engineer Bove stated that he is waiting certain income surveys.

Engineer Bove reported that the draft bidding documents are being submitted to DCNR for the Olmsted Park Development Project. He stated that once approval to advertise for said bids are received for final design approval from DCNR, he would like approval to advertise for bids.

A motion was made Mrs. Kessler, second by Mr. Uskuraitis, to approve the Engineer's request to advertise for bids regarding the Olmster Park Development Project. Motion carried.

Engineer Bove requested that Council consider the closing of 13th Street for the purpose of having this street use as a staging area during work on this Project.

Engineer Bove requested authorization to proceed with the preparation of plans and bidding documents required for the Vandergrift Casino Theater & Library Improvement Project-Phase 2. He stated that the project, in the amount of \$419,513.00 grant, funded by Local Share Account Grant. He also stated that the grant covers all engineering cost.

A motion was made by Ms. Clayton, second by Ms. Kessler, to approve the aforementioned request. Motion carried.

Engineer Bove reported that Peoples gas is planning to continue the installation of new gas lines on Hancock Avenue, and include work on 15th Street and all of Washington Avenue.

Mrs. Wilson stated that she has reguested a site meeting with the gas company to review this work.

BOROUGH OF VANDERGRIFT ORDINANCE NO. 4 OF 2023

AN ORDINANCE OF THE BOROUGH OF VANDERGRIFT, COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA, AMENDING CHAPTER 311 OF THE VANDERGRIFT BOROUGH CODE REGARDING NOISE DISTURBANCES AND PROHIBITIONS WITHIN THE BOROUGH.

WHEREAS, the Borough of Vandergrift is empowered to establish Ordinances to protect the health, safety, and welfare of the public and for the benefit of the residents, citizens and general public of the Borough of Vandergrift by and through the powers granted under and pursuant to the Borough Code of the Commonwealth of Pennsylvania at 8 Pa.C.S. Section 101 et. seq.; and,

WHEREAS, in order to protect the health, safety and welfare of the public and for the benefit of residents, citizens, workers and general public of the Borough of Vandergrift, the definitions and parameters regarding noise disturbances within the Borough of Vandergrift must be amended or established to deter nuisances and prevent the disturbance or interference with the peaceful enjoyment of property of Borough residents;

NOW THEREFORE, the Borough of Vandergrift does hereby enact and ordain as follows:

CHAPTER 311 - NUISANCES

Section 311-1. Definitions and Interpretation

Section 311-1 of the Code of the Borough of Vandergrift shall be amended to include the following new subsection 311-1(C)(11) for the purpose of clarifying and regulating the times when noise disturbances are prohibited within the Borough as follows:

- (C)(11) Any noise disturbance is prohibited between the hours dusk to dawn (unless otherwise identified in this Chapter) that:
 - (i) Endangers or injures the safety or health of humans or animals;
 - (ii) Annoys or disturbs a reasonable person of normal sensitivities and sensibilities; or
 - (iii) Endangers or injures any personal or real property.

REPEALER

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of any inconsistency.

SEVERABILITY

If any clause, sentence, paragraph or part of this Ordinance, or the application thereof to any person or circumstance, shall for any reason by adjudged by a court of competent jurisdiction to be

invalid, such judgement shall not affect, impair or invalidate the remainder of this Ordinance nor the application of such clause, sentence, paragraph or part to other persons or circumstances, directly involved in the controversy in which such judgement shall have been rendered. It is hereby declared to the legislative intent that this Ordinance would have been adopted had such provisions not been included or such persons or circumstances been expressly excluded from their coverage.

CODIFICATION

The provisions of this Ordinance shall be codified by update of the Code of the Borough of Vandergrift.

EFFECTIVE DATE:

This ordinance shall be effective immediately.

RESOLVED that the Borough of Vandergrift does hereby adopt a Policy for the use of public property of the Borough of Vandergrift, modifiable, from time to time hereafter by action of the Council of the Borough of Vandergrift, to amend the Policy and to attach thereto such future guidelines, as determined from time to time, which are in the best interests of the health, safety, welfare of the citizens of the Borough of Vandergrift.
