Ladies and Gentlemen,

Please see my requested agenda items below for the Monday, February 5, 2024 Council meeting:

- 1. <u>2024 CDBG Application</u> Since we have not received new income surveys as we requested, we will use the previous surveys.
- Olmsted Park Development On behalf of the Borough, we uploaded the required responses regarding
  the legal services as an in-kind cost and we have submitted the questions as to where these costs may be
  eligible so the Budget can be revised accordingly.
- 3. <u>Columbia Avenue Parking Lot Rain Gardens & Tree Pits</u> We completed the 3<sup>rd</sup> batch of revisions required by DEP we are happy to report that the NPDES Permit has been approved by DEP. Please note that WCD reimburses the Borough for the engineering costs as approved by the Borough Resolution 7 of 2022 and the agreement with PennDOT and the WCD.
- 4. <u>Vandergrift Casino Theater and Library Building Improvement Project Phase 2</u> With authorization granted at the December 2023 Council meeting, we are proceeding with the preparation of plans and bidding documents required for this project. As stated previously, the Engineering costs are included in the Grant. Please advise if our office is to prepare the reimbursement requests for the Borough.
- 5. <u>PNG Line replacements</u> Please note that the Street Excavation Permits are being approved with the conditions identified in the permit packages and the permit fees to be paid to the Borough for the <u>Sherman Avenue Project Phase 2</u> and the <u>Washington Avenue Project</u>. Please advise if Council has any concerns.
- 6. <u>MAAT Upper West Vandergrift Sanitary Sewer Connection</u> We have reviewed the proposed plans and agreement and have provided our report to the Borough. A copy will be sent to MAAT's Engineer upon Council authorization. Note that reimbursement of Engineering cost is part of the resolution 4 of 2023.
- 7. <u>Allegheny Township Sanitary Sewer Customers</u> Please advise if Council would like us to assist in the verification of the total number of customers in the Vandegrift Sewer System.
- 8. <u>Upper West Vandergrift Sewer Inspection</u> Please advise if Council would like us to assist in the inspection of the sewers and manholes in this branch of the sewer system and what level of inspections are required (i.e. visual manhole inspections or internal). Note that internal inspections may require quotations, due to the amount of cost.

Topics of discussion: Borough of Vandergrift Insurance Conditions and Requirements proposed change

Topic 1: Vendor insurance required 30 days prior

Proposal to make vendor insurance requirement 72 hours before the event. Weather is a factor in any event.

Once purchased the insurance is not refundable and weather 30 days prior to an event is hard to predict.

72 hours gives vendors a chance to watch the weather and still be able to purchase insurance and provide copies of insurance before the event.

Topics of discussion: Borough of Vandergrift Public Property Cleaning Agreement proposed change

Topic 1: Item 2 Separation Fee

Proposal to remove \$250 separation fee.

Requiring mandatory separation is unsafe and unsanitary and proposes a health risk to volunteers.

Proposal to change requirement to 'recycling must be made available for the public during event. Event is responsible to retrieve recycling bins from the borough for placement during the event. Recyclables will be retrieved by the Borough of Vandergrift"

Topics of discussion:Borough of Vandergrift Public Property Use Policy proposed change

Topic 1: Item 1 Insurance requirement before approval Proposal to remove proof of insurance supplied with application under item 1.

Applicant can not purchase event insurance without an approval of use of requested property on the requested date. If the date is not approved for any reason the money paid for the event policy is a loss to the applicant.

Item 1 contradicts Item 4 which gives the applicant 30 days before the event to show proof of event insurance.

Topic 2: Item 6 Deposit for cleaning and garbage removal

Proposal to change from \$500 to \$100

\$100 deposit allows for smaller events to afford the deposit

Topic 3: Item 10 Police presence

Proposal to set a definition of Crowd Size that will be the requirement for police presence.

By not requiring police for equal sized events of a different nature (I.e. Sunday Church Gathering vs. a Pride event) the borough would be

violating civil rights of the participants.
