# BOROUGH OF VANDERGRIFT POLICE CIVIL SERVICE COMMISSSION RULES AND REGULATIONS AMENDMENT

The Borough of Vandergrift, County of Westmoreland and Commonwealth of Pennsylvania does hereby set forth the following amendments to the Civil Service Rules of the Borough of Vandergrift enacted by Resolution of 4 of 2018 on the 2<sup>nd</sup> day of July, 2018, and further amended by Resolution 2 of 2022 on the 7<sup>th</sup> day of February, 2022, said amendment to the rules to be enacted as follows:

# CHAPTER 3. FULL-TIME POLICE OFFICERS

# A. APPLICATIONS AND QUALIFICATIONS

The provisions of Section 3.4 are hereby repealed and shall be replaced, in whole, with the following:

3.4 Age and Residency Requirements.

The applicant must have reached their 20th birthday before the deadline for submitting completed applications. Newly hired police officers are required to reside within a 13-mile radius of the Borough Administration Offices no later than the last day of the successfully completed probationary period.

The Civil Service Commission, acting at an advertised meeting on this date December 18, 2024, does hereby enact the same and recommend that the Council of the Borough of Vandergrift adopt the same by Resolution at a public meeting, in order for the same to become the rules of the Civil Service Commission for the Borough of Vandergrift.

# **RESOLUTION 2 OF 2025**

A RESOLUTION OF THE BOROUGH OF VANDERGRIFT, COUNTY OF WESTMORELAND AND COMMONWEALTH OF PENNSYLVANIA, APPROVING SERVICE AGREEMENT WITH THE MUNICIPAL AUTHORITY OF ALLEGHENY TOWNSHIP FOR LABELLE VUE ROAD SEWAGE PLAN PURSUANT TO 23 P.S. § 2305(a)

WHEREAS, the Borough of Vandergrift and the Municipal Authority of Allegheny Township ("MAAT") have discussed and jointly prepared a comprehensive Service Agreement related to MAAT's plan to implement a sewage plan designed to eliminate certain facilities and install new facilities at or near LaBelle Vue Road and south of Nevada Avenue, which shall connect MAAT sanitary sewer lines and facilities owned and maintained by the Borough of Vandergrift.

WHEREAS, the Borough of Vandergrift is authorized to jointly cooperate with other local government entities or authorities in the exercise or performance of its respective governmental functions, powers or responsibilities pursuant to 23 P.S. § 2303; and,

WHEREAS, in order to continue to adequately protect the health, safety and welfare of the Borough of Vandergrift residents, the Borough of Vandergrift has determined that intergovernmental cooperation with MAAT with respect to MAAT's desired implementation of the sewage plan outlined in the Service Agreement attached hereto is in the best interests of the residents of the Borough of Vandergrift;

NOW THEREFORE, the Borough of Vandergrift does hereby resolve as follows:

RESOLVED, that the Borough of Vandergrift shall execute the attached Service Agreement and permit MAAT to move forward with implementation of the sewage plan outlined therein.

Thank you for your consideration and we look forward to working with you again on this fantastic event.



- (4. Reappointment for 2025 Request approval of reappointment to the position of Borough Engineer.
  - 5. <u>Ninth Street Retaining Wall Replacement Project</u> (CEAP Grant) Costs for Geotechnical Engineering and drilling received. Request authorization to proceed with Drilling & Geotechnical Engineering.
  - 6. 219 225 Grant Avenue Partial Building Collapse No update.
  - 7. PNG Gas Line Replacement Projects
    - a. Whittier Street Project Planned to start in January 2025.
    - b. Franklin Avenue Project Planned for July 2025.

WHEREAS, the Civil Service Rules of the Borough of Vandergrift were enacted by Resolution of 4 of 2018 on the 2<sup>nd</sup> day of July, 2018, and further amended by Resolution 2 of 2022 on the 7<sup>th</sup> day of February, 2022; and

WHEREAS, the Council of the Borough of Vandergrift has received the recommendation of the Borough of Vandergrift Civil Service Commission to amend the Civil Service Rules to change the minimum age requirement from age twenty-one (21) to age twenty (20), and has determined that the amendment of the Civil Service Rules of the Borough of Vandergrift is in the best interest of the public health, safety and welfare of the residents of the Borough of Vandergrift; and

WHEREAS, the Civil Service Rules which are the subject of this resolution shall repeal any prior Civil Service Rules and shall replace the same with those attached hereto and incorporated herein by reference as though fully set forth herein at length;

NOW THEREFORE, the Council of the Borough of Vandergrift does RESOLVE as follows:

RESOLVED, that the Council the Borough of Vandergrift, on the 13th day of January, 2025, does hereby repeal and revoke any provisions of the Civil Service Rules of the Borough of Vandergrift in conflict with the amended provisions as adopted by the Civil Service Commission of the Borough of Vandergrift and which said rules were approved by the Board of the Civil Service Commission on the 18th day of December, 2024, said rules attached hereto and made a part hereof as Exhibit "A" amending Chapter 3, Full-Time Police Officers, Subsection A, 3.4 – Age and Residency Requirements.

IT IS FURTHER RESOLVED, that said amendments, as approved by the Civil Service Commission of the Borough of Vandergrift on December 18, 2024 are hereby incorporated into the Vandergrift Borough Police Civil Service Rules and Regulations adopted by the Borough of Vandergrift Civil Service Commission and enacted by the Council of the Borough of Vandergrift by Resolution of 4 of 2018 on the 2<sup>nd</sup> day of July, 2018, and further amended by Resolution 2 of 2022 on the 7<sup>th</sup> day of February, 2022.
