Engineer Lucien Bove stated that he has conducted an inspection of the building that collapsed at 521 Franklin Avenue. (See page 3-A)

Mr. Bove stated that on January 5th, the Kiski Valley Water Pollution Control Authority will begin to monitor the flow to the Authority. He stated that the equipment needs to be cleaned weekly, and that the Borough needs to insure that certain factors are adhered to. He stated that the study will compare flow during wet and dry times.

Mr. Bove informed Council that the water company will be replacing a water line from the end of 8th Street, going across the Kiski River, to service Parks Twp.

Mr. Bove stated that he has submitted request for a waiver to DEP regarding NPDES MS4 2018 Permit Cycle. (See page 3-B)

Ladies and Gentlemen:

The above referenced structure was extensively damaged by a sudden collapse on December 31, 2016. The roof and the second floor completely collapsed onto the first floor. The majority of the walls of the second and first stories have collapsed outward onto adjacent properties, parking areas and the street and sidewalk of Franklin Avenue. On January 3, 2017, I conducted an inspection of the structure from a safe distance and observed the following conditions (see attached photos): The entire roof and the second story walls and floor have been destroyed. Structure members which have not collapsed have been compromised. The remaining portions of the walls and floors are in a state of imminent collapse. The structure is not safe to conduct any testing, sampling or surveying. Supporting structural members have been compromised rendering the remaining structural elements unsound.

This building is structurally unsafe and presents a clear and present danger to the community and adjacent residences and properties. It must be condemned until it can be safely demolished. The majority of the structure has already collapsed. Unless an evaluation certified by a licensed structural engineer is submitted to the Borough indicating otherwise, the remaining portions of this structure need to be immediately demolished. The surface of the ground needs to be restored in a manner which will not adversely affect adjacent properties, and the sewer service lateral(s) must be capped and sealed in a manner which prevents infiltration of water into the sanitary sewer system.

Ref: Request for Advanced Written Approval of Waiver NPDES MS4 2018 Permit Cycle

Vandergrift Borough, Westmoreland County

Ladies and Gentlemen:

On behalf of the Borough of Vandergrift, we are hereby requesting advanced approval of a waiver under the NPDES Storm Water Discharges from Small Municipal Separate Storm Sewer Systems (MS4). Attached please find a copy of Form 3800-PM-BCW0100e (5/2016). Also attached please find detailed maps of the storm sewers, including outlets and points of connection to other MS4's, a Zoning Map and the TMDL for the Kiskiminetas River.

Justification for the waiver request is as follows:

- According to the 2010 census, the population of Vandergrift is 5,205.
- The Borough does not have the financial resources nor an established funding mechanism necessary to implement the pollution reduction plan and all requirements of the full MS4 regulations.
- The TMDL for the Kiskiminetas River is under the category of Acid Mine Drainage. The Borough's separate storm sewer system does not contribute in any way to the TMDL of acid mine drainage.
- There is little that the Borough could do to reduce pollutants, other than sediment which could be implemented through street sweeping and storm sewer cleaning.
- The separate storm sewer area of the Borough is primarily residential. There is a railroad and industrial area along the river.
- Borough storm drains do not connect directly to the Kiskimentas River. Many connect to the PennDOT System and several others connect to the railroad culverts and Steel Plant system.
- All outfalls to the river in the separate storm system area are by way of either the Norfolk Southern Railroad culverts or the Allegheny Ludlum (now ATI) Vandergrift Plant storm sewer system.
- The sewers in the downtown business district of the Borough are combined. Therefore, the outfalls are permitted and owned and operated by the Kiski Valley Water Pollution Control Authority (KVWPCA).
- After many years of impairment, the once foul smelling, discolored Kiskiminetas River was voted Pennsylvania's River of the Year in 2000 by DCNR, primarily due to its water quality improvement.
