TAX ORDINANCE 2 OF 2018

AN ORDINANCE OF THE BOROUGH OF VANDERGRIFT, COUNTY OF WESTMORELAND, AND COMMONWEALTH OF PENNSYLVANIA FIXING THE TAX RATE FOR FISCAL YEAR 2018.

BE IT ORDAINED AND ENACTED, and is hereby ordained and enacted by the Council of the Borough of Vandergrift, County of Westmoreland and Commonwealth of Pennsylvania:

Section 1. That a tax be, and the same is, hereby levied on all property and occupations within the said Borough subject to taxation for Borough purposes for the year 2019 as follows:

Tax rate for general Borough purposes, the sum of twenty-eight (28) mills on each dollar assessed valuation.

Making a total tax rate for all Borough purposes of twenty-eight (28) mills on each dollar of assessed valuation.

Section 2. That any ordinance, or any part of any ordinance, conflicting with this ordinance shall be hereby repealed insofar as the same affects this ordinance.

GENERAL GOVERNMENT REPORT:

President Chvala commented on the petition received Byron Brown to rename the Vandergrift Bridge. (See page 4-A)

Solicitor Loperfito stated that he addressed this matter with PennDot and that the petition should now be sent to Parks Township.

President Chvala questioned the matter of lifting the moratorium on handicap parking.

A motion was made by Mr. Collini, second by Mr. Sciullo, to authorize the Solicitor to prepare an ordinance amending the issuance of handicap parking.

A motion was made by Mr. Sciullo, second by Mr. Rametta, to accept the General Government Report. Motion carried.

RECREATION REPORT:

Chairperson Basile stated that all parks will be closed for the winter, and advise the Police Department to not open any of the park facilities.

Mr. Basile stated that there is a leak in the shed roof at the Pool. He stated that he will be obtaining quotes for this repair.

Renaming Vandergrift Bridge: Byron and Sylvia Brown and Beth Patoka approached Parks on June 19, 2017 to change the name of the Vandergrift Bridge to Rudy Minarcin Bridge. Parks will support and told the interested parties that they needed a petition signed by 10% of the voters. Vandergrift was also approached in June 2017. Per our Solicitors office research, there are no requirements under state law for a municipality, which adjoins a bridge, to provide consent or authority for the naming of a state bridge, although the consent will provide greater likelihood of its approval. Currently, all that is required is that a senator or member of the House submit in bill form a piece of legislation to change the name of a bridge. In 2014, there was "talk" of a potential proposal that would allow citizens to propose names directly to the secretary of transportation by submitting a petition showing local support and a legislative sponsor. However this proposal was never introduced.

Vandergrift is supportive, we will defer to legislator we are neutral on name.

A motion was made by Mr. Collini, second by Mr. Rametta, to accept the Recreation Report. Motion carried.

SOLICITOR'S REPORT:

Solicitor Loperfito stated that he has prepared a Quality of Life Ordinance regarding the establishment of issuing tickets for violations, such as high grass, accumulation of junk, setting the first violation at \$25.00. He stated that tickets will be issued by the Code Officer.

Solicitor Lopefito stated that he has prepared Ordinance No. 1-2019, amending Section 382-6 of the Borough code, whereby the capping of unused sewers thereby rendering the property unoccupiable. (Sed pages 5-A thru 5-C))

A motion was made by Mr. Maszgay, second by Mr. Collini, to advertise Ordinance No. 1-2019 for adoption. Motion carried.

Solicitor Loperfito questioned whether Council wanted him to draft two types of uses for Kennedy Park. He stated that the first would be regarding the No. 1 Fired Department carnivals, and the second would be regarding Tiny Cause events.

Solicitor Loperfito stated that a motion is needed to adopt the regular monthly meetings of the Vandergrift Borough Council to be set for the first Monday of the month, at 7:00 pm. (See page 5-D)

A motion was made by Mr. Sciullo, second by Mr. Collini, to advertise the aforementioned matter. Motion carried.

Solicitor Loperfito stated that a motion is need to adopt the regular monthly meetings of the Vandergrift Planning Commission to be set for second Monday of each month, at 7:00 pm. (See page 5-E)

A motion was made by Mr. Sciullo, second by Mrs. Wilson, to advertise the aforementioned matter. Motion carried.

BOROUGH OF VANDERGRIFT

ORDINANCE NO. 1 OF 2018 2019

AN ORDINANCE OF THE BOROUGH OF VANDERGRIFT, COUNTY OF WESTMORELAND, AND COMMONWEALTH OF PENNSYLVANIA AMENDING SECTION 382-6 OF THE CODE OF THE BOROUGH OF VANDERGRIFT, PERMIT FOR CONNECTION, AS ASSOCIATED WITH RESIDENTS WHO ELECT TO CAP THEIR SEWER TAP THEREBY RENDERING THE PROPERTY UNOCCUPIABLE FOR HUMAN HABITATION.

WHEREAS, the resident of the Borough of Vandergrift may make an application to permanently remove their sewer tap and cease the payment of debt service fees associated with said property and in the process thereof, rendering said property uninhabitable for human occupancy; and,

WHEREAS, the Borough of Vandergrift deems this opportunity to be limited in nature and affecting only those properties that do not possess a structure thereon and only if there is no intent to rebuild on the property within five years of the date of the application to terminate the sewer tap; and,

WHEREAS, the Borough of Vandergrift is authorized to enact such an Ordinance pursuant to the power granted to the Borough of Vandergrift under the Borough Code of the Commonwealth of Pennsylvania, 8 Pa.C.S. §101, et seq. (including supplements);

NOW THEREFORE, Section 382-6 of the Code of the Borough of Vandergrift, as codified by the Borough of Vandergrift is hereby amended as follows:

Section 382-6 - Application for Removal Sewer Tap

The provision shall be added to Section 382-6 of the Code of the Borough of Vandergrift:

382-6(L) – An applicant may apply to the Borough of Vandergrift for removal of a sewage tap on property owned by the applicant subject to the following conditions:

- 1. The applicant shall complete an application to remove and/or cap the sewer tap on a form provided by the Borough of Vandergrift;
- 2. The application to the Borough of Vandergrift to cap or remove a sewer tap may only be submitted to the Borough of Vandergrift if there is no structure on the subject lot, piece or parcel of land in question and if there is no intended or actual construction on the property within one year after the application is submitted to the Borough of Vandergrift;
- Any connection within five (5) years of application for 3. termination, to the sanitary sewer system of the Borough of Vandergrift on the lot, piece or parcel of land upon the termination was requested, shall require said applicant to pay a new tap fee to the Borough of Vandergrift, including any capacity fee portion due and payable to the Kiski Valley Water Pollution Control Authority, and in addition thereto, said applicant shall be required to pay any and all debt service fees, sewer recovery fees or other fees which would have been due and owing to either the Borough of Vandergrift from the date of tap termination to the date of application for a new tap on the lot, piece or parcel of land in question and, upon application, an application fee in the amount of \$500.00 made payable to the Borough of Vandergrift or such amount, as may be amended, from time to time, hereafter, by resolution of the Council of the Borough of Vandergrift;
- 4. Removal and/or capping of the sewer tap shall be performed by a contractor approved by the Borough of Vandegrift;
- 5. A representative of the Borough of Vandergrift shall be present to inspect at the time of the removal and/or capping of the sewer tap in question;
- 6. Removal of and/or capping of the sewer tap shall be performed as directed by the Borough of Vandergrift.
- 7. The applicant shall be responsible for all costs and expenses associated with the removal and/or capping of the sewer tap and the inspection by the Borough of Vandergrift;
- 8. No capping or removal of the sewer tap shall be permitted if it is the intent of the applicant to construct on the property in question within one year of the date of application for capping or removal of the sewer tap.

Severability:

If any sentence, clause, section or part of this Ordinance is, for any reason, found to be unconstitutional, illegal or invalid, such unconstitutional, illegal or invalid part or portion shall be removed and shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared that it is the intent of the Borough of Vandergrift that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herewith.
