MINUTES:

The Minutes of the May 2, 2022 meeting were approved by motion of Mr. Holmes, second by Mr. Sarno. Motion carried.

VISITORS:

A motion was made by Mrs. Wilson, second by Mr. Holmes, to hear from visitors at this time. Motion carried.

David Coleman, 303 Sherman Avenue, requested that Council to remove the tree along the street due to the tree limbs are hitting his house

Mrs. Kessler stated that she would have an arborist determine if the tree needs to be removed or just trimmed.

Mr. Coleman requested that a tree within the former Sherman Avenue Park be removed. He explained that there are dead tree limbs hangining over 9th Street and that he is concerned that the may fall on someone.

Mrs. Wilson stated that this tree fails within Norfolk-Southern property. She stated that a letter was send to Norfolk-Southern by the Solicitor and received no response.

Tammy Domiano, 109 Lowell Street, complained about the tree limbs extended onto her property from 109 ½ Lowell Street. She stated that her husband had fallen on her sidewalk as a result of leaves and ice build up.

President Chvala stated that is a civil matter between Mrs. Domiano and the owner of the abutting property.

Solicitor Kraft recommended that she contact her attorney for the purpose of filing a civil action.

President Chvala requested the Solicitor to look into this matter further.

William Spang, 219 Holmes Street, addressed Council in regards to his basement flooding as a result of a heavey downpour on May 6^{th} .

Mrs. Wilson stated that there were serveral properties that incurred flooding problems following the rain downpour and that the fire departments were called to out pump out water from basements in town.

Don Detar, 213 Lowell Street, reported high grass at the corner of Emerson & Lowell, and Hancock Avenue.

President Chvala stated that the owner of these areas have already been cited.

Jimmy Williams, 126 Oregon Avenue, stated the police have responded to numerous complaints about barking dogs at a residency on Oregon Avenue He questioned if there is an ordinance limiting on the number of dogs one can own.

Mr. Holms stated that he will look into to this matter.

Dear neighbor municipality:

I am writing on behalf of the Alle-Kiski Intergovernmental Council (AK IGC) which currently represents seven member municipalities in northern Westmoreland County. This letter not only serves to provide you with a brief overview of this intergovernmental effort thus far, but also to invite you to attend an upcoming meeting and to ask you to consider joining the AK IGC as a member government in the future.

The AK IGC is a voluntary organization of member governments which meet for the purpose of discussing, planning, and undertaking joint, intergovernmental activities. The Council serves as a forum for the identification of intergovernmental issues, facilitates agreements and actions for specific programs and projects, and administers these activities as agreed to by its member governments. This effort stems from the Planning District process where 11 Alle-Kiski communities participated in a number of land use, mobility, and intergovernmental exercises to align county strategies with local priorities.

Beginning in August 2021, the seven communities of Allegheny Township, Arnold, East Vandergrift, Lower Burrell, New Kensington, Upper Burrell Township, and West Leechburg formally committed to working together in an intergovernmental capacity with administrative support provided by the Westmoreland County Planning Division. Over the last several months, the AK IGC has identified a number of priorities to advance. Top AK IGC priorities include: initiating a regional/joint code enforcement program; exploring shared services/equipment and joint purchasing opportunities; marketing

developable (available/vacant) property within the Alle-Kiski; establishing a riverfront trail and coordinating other trail improvements; and initiating a regional/joint blight inventory project.

As we continue our shared work and ready ourselves for a second year of the AK IGC's operation, we ask that you consider attending an upcoming meeting to learn more about this effort. The AK IGC meets at New Kensington City Hall, located at 301 Eleventh Street, New Kensington, PA 15068, on the third Thursday of every month at 5PM, except for the month of December. Meetings are open to elected or appointed local government officials and the public.

This is an exciting time in the Council's development I am hopeful that by working together through the AK IGC to advance mutual priorities, we can address shared challenges and improve the overall quality of life in our Alle-Kiski communities. We hope that you consider attending a meeting soon.

BUDGET & FINANCE REPORT:


Chairperson Clayton stated that copies of the General Fund, State Aid Fund, and the Pool Fund budgets have been provide to members of Council.

Ladies and Gentlemen,

I will need to attend another Council meeting at the same time on June 6th. Therefore, I am submitting this report in advance, in case anyone has any questions before the meeting. This report summarizes activities, projects, and work performed during the past month in addition to the preparation for and attendance of regular and scheduled meetings and also includes our requested agenda items:

2022 CDBG Street Reconstruction Project

The Preconstruction meeting was held at the Borough office May 6th with the County, Contractor and the Borough. Work is scheduled to start June 1st and be completed by June 3rd. Note that this project was specifically approved for early 2022 funding.

2021 CDBG Street Reconstruction Project - Sherman Ave., LaFayette Ave. & 7th Street

While Folino is in town, they plan to address this issue.

2021 Casino Theater and Library Building Improvement Project

Roofing Replacement

Fuller Roofing is scheduled to start roofing work June 6th. The contract amount for the roofing work is \$105,948.

Project 70 Timber Sale

Since no bids were received the first time, the timber sale was advertised a second time. One bid was received within the time specified which is to be opened and read aloud at the meeting. If acceptable, the bid may be awarded contingent upon review by the Forester, Dave O'Barto, or tabled for review, or rejected.

Driveway Permits No permits issued in May - 2 requests for driveway requirements: 411 Jackson & 818 Holland.

Olmsted Commons

In order for this project to proceed, we look forward to meeting with the organizations that are interested in, and/or have made financial contributions and commitments toward the Volunteer Efforts.

Joseph A. Petrarca Memorial Swimming Pool Rejuvenation Project - DCED Grant

Correspondence regarding the procedure to repair a tear in the liner without voiding the warranty.

Street Excavation Permits - Several repair permits issued for water and gas line leaks.

Columbia Avenue Street-Tree, Pervious Sidewalk and Parking Lot Rain Garden Project

We made a third Pa-1 Call and (finally) all the utilities have been marked and we have located the markings since they sometimes rapidly fade away.

Digital Designs

We responded to questions regarding the requirements to expand this Non-Conforming Use in a Residential Zoning District. Digital Designs will first need to request a Zoning Hearing with the ZHB for any expansion. Such request should also include any setback or other dimensional variances that they may need from the Zoning Hearing Board. This expansion may also require a Site Development and Stormwater Management Plan.

Sewer Issues

37th Street Drainage and Heave issue

The repairs were discussed at the May 2nd meeting. Note that some of the swale and grading work will be on private property and permission from the owners (Burke and Tvrdovski) will be needed.

Alabama Avenue Collapsed Storm Sewer

We discussed possible repair options and placed a Pa-1 Call for the utilities to be located and marked. The Borough plans to purchase the materials and solicit costs for Equipment and Operator to install the pipe and rock lining.

Proposed Sewer Connection - Homes in Allegheny Township along LaBelle Vue Road - No update.

Abandoned and/or Unsafe Buildings

906 Holland Street - The permit to demolish the structure has been issued.

Demolitions Approved for 2022 County Demolition Funding

109 Washington Avenue - Former Twin County Lodge Home Association

111 Washington Avenue - Former Brock Automotive

Notice of Unsafe Structural Conditions

117½ (Rear) Longfellow Street – As of May 31st, we've received no response to the 2nd certified mail 30-day notice sent April 8th, nor has any action been taken on this property. Further actions may be required by the Borough to notify the owner before enforcement actions can be taken. We recommend seeking the solicitor's advice on how to proceed with enforcement actions for this property.

122 Franklin Avenue – The certified mail 30-day notice was received April 4th. As of May 31st, no action has been taken on this property. Therefore, we recommend that enforcement actions be taken.

Kennedy Street Preliminary Speed Hump Study

We began researching PennDOT Publications 383 & 46 for requirements and suitable Traffic Calming techniques. We started gathering the field data and photos. Speed Humps and Tables are considered unconventional traffic control devices and as such, should only be installed after careful consideration, engineering studies and public involvement. Items that need to be considered include but are not limited to: funding source; cost of construction of devices, signs and pavement markings; cost of on-going maintenance; effect on Emergency Vehicles and response times; effect on snow removal; effect on drainage; ADA requirements; legal issues; etc. The Study and Approval process, construction and maintenance will need to follow PennDOT guidelines to protect the Borough from claims that the devices caused or contributed to an accident, or were improperly installed or inadequately maintained.

TREE & LIGHT REPORT:

Chairperson Kessler reported that Brian Altman Tree Service will be removing a tree at 301 Hancock Avenue, 15th St. in park, and at 112 Holmes Street, to include stump removals at a cost of \$4,500.00.

Mrs. Kessler stated that she would like to address the trees at the Highrise on Lincoln Avenue.

Mrs. Kessler stated that the Vets are requesting that the tree located by the Vandergrift Bridge be either trimmed or removed.

Mrs. Kessler stated that Pomfrets Paints and Janni's Pizza wish to plant two trees in front of their businesses in memory of John Pomfret.

A motion was made by Mr. Holmes, second by Mr. Sarno, to approve the aforementioned matter. Motion carried.

A motion was made by Mr. Holmes, second by Mr. Sarno, to accept the Tree & Light Report. Motion carried.

GENERAL GOVERNMENT REPORT:

President Chvala stated that her committee met for the purpose of discussing a lease agreement between the Borough and the Kiski Valley Lancers Football Organization. She read the following statement regarding this matter. (See page 7-A)

At this time, a motion was made by Mr. Holmes, second by Mr. Sarno, to entering into a lease agreement between the Borough of Vandergrift and the Kiski Valley Lancers for the use of Davis Field for a one-year period, to include the 2022 football season, and to state that the KVL will maintain the inside facilities of the field and the Borough the outside. Motion carried.

Mr. Holmes stated that the Borough will have an independent inspection of the facilities within the field.

A motion was made by Mr. Holmes, second by Mrs. Wilson, to accept the General Government Report. Motion carried.

RECREATION REPORT:

SOLICITOR'S REPORT:

Solicitor Kraft requested Council to authorize the advertisement of Ordinance No. 1-2022, which prohibits the placement of certain items for refuse collection.

A motion was made by Mr. Holmes, second by Ms. Clayton, advertise for adoption Ordinance No. 1-2022 at the July $5^{\rm th}$ meeting. Motion carried.

Solicitor Kraft requested Council to authorize the advertisement of Ordinance No. 2-2022, which sets a weight limit of 5 tons on Arizona Avenue.

A motion was made by Mr. Holmes, second by Mrs. Wilson, to advertise for adoption Ordinance NoI 2-2022 at the July $5^{\rm th}$ meeting. Motion carried.

A motion was made by Mr. Holmes, second by Mrs. Wilson, to accept the Solicitor's Report. Motion carried.

The Governing Committee consisting of Kathleen Chvala, Tom Holmes and Christine Wilson met with the President of KVL, Mr. Kyle Harris and Mr. Mark Flemm on May 17, 2022. We discussed two items, a short term lease, good for a year, to have the Davis Field available for this year and a long term lease of five years.

KVL will maintain the inside of the field and the Borough will maintain the outside, unless major repairs are necessary. KVL will have a grounds keeper to maintain the field. Brian Anderson is presently the grounds keeper and Josh Woods is presently cutting grass. KVL maintains the grass year round. There will be no other activities, outside of football, without Borough Council approval.

KVL only uses the Jackson side bleachers and concession stand.

The Borough Recreation Committee, chaired by John Uskuraitis, will take care of the demolition and removal of the dilapidated structure on the Linden side of the field along with trees and trash near the basketball court end of the field.

KVL is going to purchase a new dumpster and is going to change the sign on the bypass side of the field to "Home Of The Kiski Valley Lancers". KVL also needs to replace the scoreboard.

Davis Field is a Historic Site.

Larry advised us that Att'y Kraft is working on a stadium lease agreement.

Tom Holmes brought Chris Cerminare, P.E. to do a Field Inspection of the Davis Field from A.E. Dynamics out of New Kensington on Tuesday, May 24th at a cost of \$1,500.00.

Once I see what Att'y Kraft Proposes, I will choose a committee to continue working with KVL on a five Year contract.
