Dear Vandergrift Borough Leaders,

Please accept this letter and request from the Vandergrift Presbyterian Church. Our address is at 195 Washington Avenue. For the past few months we have been having problems with our sewer system. After several quotes from contractors, and through the use of their underground cameras, it has been determined that there is a break in the line at the connection to where our line connects with the main sewer line on Washington Avenue. It appears that the main line has settled and as a result has separated from our connection to the church line.

The contractor that we would like to use has been in touch with several people from Vandergrift Borough to which it was stated that he would have to dig from curb to curb in fixing the problem with the sewer. This is a procedure that is requested by all contractors, per borough regulations. That is quite an expense for any organization, business as well as a church. For the Vandergrift Presbyterian Church to fix the problem it would be approximately \$40,000. This would entail fixing the problem with the sewer, as well as dig up the pavement curb to curb, mill it, get rid of any dirt and old asphalt, and repave the road. Our concern is that the problem could be corrected with a patch of approximately 15' by 15' of the road being dug up and repaired and not having to go curb to curb as was stated to us by the contractor. This procedure could be done at an approximate cost of \$20,000.

We as the Property Committee of the Vandergrift Presbyterian Church session, are requesting your consideration in allowing the church to move forward in correcting this ongoing problem with the broken pipe and issues with the sewer in allowing our contractor to only dig what is necessary to eradicate our problem on the premise that all work that is done to the street will be repaired correctly. Allowing this to happen would be a huge savings to the church and much appreciated by not only the church session but to the Covenant Partners, the congregation, of the church as well.

Mr. Basile stated that Anthony Ferrante has agreed to pay \$2900.00 for the installation of the light poles.


