MINUTES:

The Minutes of the May 6, 2019 meeting were approved by motion of Mr. Collini, second by Mr. Basile Motion carried.

VISITORS:

A motion was made by Mr. Maszgay, second by Mr. Collini, to hear from visitors at this time. Motion carried.

David Hill, 213 Emerson Street, questioned when action will be taken to correct the constant flooding in his basement.

Mrs. Wilson stated that the Borough Engineer is to get prices for the repairs relative to this problem.

Mr. Hill stated that he will need help in replacing the damages.

Solicitor Loperfito requested that Mr. Hill obtain estimates and provide them to the Borough.

Bill Spang, 219 Holmes Street, stated that a grass rut is developing in his yard, especially during a rainfall. He stated that the rut is growing and may be going the sewer line.

Mrs. Wilson stated that she will have the Borough Engineer schedule a meeting with Mr. Hill.

Bernett Gregg, 120 Maryland Avenue, addressed Council in regards to the new LED Street light installed at his address. He requested that this light be removed and/or replaced with the old mercury vapor light. He explained that there is too much entering his house.

Solicitor Loperfito referred this matter over to the Police & Public Safety Committee.

Melissa Adams, 307 Jackson Avenue, questioned if any action will be taken regarding the garage at 113 West Adams.

Solicitor Loperfito stated that he has written the attorney who represents the owners of said property and to advise of the condition of said garage. He stated that the letter advises the attorney that the garage is in imminent threat of collapse and are requiring the Estate and heirs to take corrective action within twenty (20) days and if no action is taken, the code official has the authority to take action to demolish said garage.

Don Detar, 213 Lowell Street, questioned why the Borough repaved 29th Street since it was recently paved and was in good condition.

Mrs. Wilson stated that the County Plannng Department directed where the money was to allocated for street reconstruction. She stated that the Borough had to accept this or loose the funding.

Ashley Hanningan, No. 1 Fire Department, stated that the Department has placed about 200 banners on poles to date, with about 50 more yet to be installed.

Julia Martin, V.I.P., stated that the Vandergrift Arts Festival will be held on July 27th.

A motion was made by Mr. Collini, second by Mr. Basile, to pay the aforementioned invoice. Motion carried with Mrs. Wilson abstaining.



RESOLUTION NO. 4 OF 2019

RESOLUTION AUTHORIZING THE FILING OF A GREENWAYS, TRAILS AND RECREATION PROGRAM SINGLE APPLICATION FOR ASSISTANCE TO THE COMMONWEALTH OF PENNSYLVANIA, DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT FOR A PROJECT KNOWN AND IDENTIFIED AS THE VANDERGRIFT POOL REJUVENATION PROJECT

WHEREAS, the Borough of Vandergrift, a municipal corporation of the Commonwealth of Pennsylvania, has determined that it is in the best interest of the citizenry of the Borough of Vandergrift to prepare and file a single application for assistance with the Department of Community and Economic Development for a Greenways, Trails and Recreation Program grant; and,

WHEREAS, the Borough of Vandergrift deems that the rejuvenation of the Vandergrift Pool is important for the community and for the health, safety and welfare of those attending and utilizing the recreational opportunities of the Borough of Vandergrift;

NOW THEREFORE, the Council of the Borough of Vandergrift does hereby RESOLVE as follows:

RESOLVED, the Borough of Vandergrift shall file an application for assistance with the Department of Community and Economic Development, from the Commonwealth Financing Authority in the amount of Two Hundred Thousand (\$200,000.00) Dollars for the Greenways, Trails and Recreation Program and any other program or programs, as applicable, for the project known and identified as the Vandergrift Pool Rejuvenation Project for the purpose of seeking funds for renovations, grading and excavating, new equipment purchases and expansion in accordance with the single application at Web Application ID 8304012 and Single Application ID 201906172434;

RESOLVED, that the Borough does authorize and direct Kathleen Chvala, President, Vernon E. Sciullo, Vice President and Peter Basile, Councilman, individually or joint signators, for any documentation, as necessary, to advance the single application for assistance and any other document or documents as required by the Department of Community and Economic Development to facilitate the grant request;

RESOLVED, that the Borough of Vandergrift designates the Borough Secretary, Stephen J. DelleDonne, or his designated successor or agent, to receive, to accept on behalf of the Borough of Vandergrift, any funding granted and to provide documentation, as needed, from time to time hereafter, to the Department of Community of Economic Development or their agent, as associated with Web Application ID 8304012 and Single Application ID 201906172434;

BOROUGH OF VANDERGRIFT ORDINANCE NO. 4 OF 2019

AN ORDINANCE OF THE BOROUGH OF VANDERGRIFT, COUNTY OF WESTMORELAND, AND COMMONWEALTH OF PENNSYLVANIA AMENDING CHAPTER 404 OF THE CODE OF THE BOROUGH OF VANDERGRIFT – SOLID WASTE; ARTICLE II – GARBAGE, REFUSE AND RUBBISH COLLECTION TO PROVIDE FOR POLICY AND RULEMAKING REGARDING COLLECTIONS AND ESTABLISHING APPROPRIATE PENALTIES FOR VIOLATION OF MATTERS AFFECTING THE HEALTH SAFETY AND WELFARE OF THE CITIZENRY OF THE BOROUGH OF VANDERGRIFT AND THE PUBLIC IN GENERAL

WHEREAS, the Borough of Vandergrift (the "Borough") has experienced an increase in garbage, refuse and rubbish in the form of furnishings and extreme quantities of garbage, refuse and rubbish which has a negative effect on the health, safety and welfare of the citizens of the Borough of Vandergrift and the public in general and it overwhelms the garbage, refuse and rubbish collection capabilities of the Borough of Vandergrift; and,

WHEREAS, the Council of the Borough of Vandergrift ("Borough Council") is desirous of amending the Code of the Borough of Vandergrift to provide for the establishment of rulemaking powers in collection activities for garbage, refuse and rubbish and the establishment of penalties and procedures for violations of the Borough Code; and,

WHEREAS, the Borough Code at 8 Pa.C.S. §3321, provides the Borough Council the authority to prescribe fines and penalties of violations of the Borough Ordinances; and,

WHEREAS, the Borough Council finds that such an Ordinance is necessary to protect the health, safety and welfare of the residents of the Borough of Vandergrift;

NOW THEREFORE, be it enacted and ordained by the Council of the Borough of Vandergrift, County of Westmoreland and Commonwealth of Pennsylvania, as follows:

Section 1. – §404-5 Administration:

A. The provisions of Section 404-5(A) are hereby deleted in their entirety and shall be replaced with the following provision:

§404-5 (A):

The collection, conveyance and disposal of refuse in the Borough of Vandergrift shall be conducted under the supervision of the Borough Street Committee, as designated by the Chairperson of the Council of the Borough of Vandergrift. The Street Committee shall have the authority to make and adopt policy regulations to be approved by the Council of the Borough of Vandergrift, setting forth days of collection, type and location of waste and waste containers and any other such matters as they deem necessary and pertinent to the collection and disposal of refuse, so long as said regulations are in accord with the provisions of this Article of the Code of the Borough of Vandergrift. The Street Committee of the Borough of Vandergrift shall set forth all said policy

regulations that they deem to be in the best interest and the health, safety and welfare of the citizens of the Borough of Vandergrift, in writing. The same shall be placed on file, with the Borough of Vandergrift and shall be made part of the minutes of the meeting in which they are adopted by the Council of the Borough of Vandergrift.

Section 2 - \$404-5(F)

B. The provisions of Section 404-5(F) are hereby deleted in their entirety and shall be replaced with the following provision:

§404-5 (F):

Charges imposed under this Article shall be due and payable in accordance with the provisions of Section 404-5 (Administration). Should any individual or entity fail or refuse to make payment timely in addition to any penalty fees assessed thereto, the Borough may file an action in the form of a citation, with a court of competent jurisdiction and upon conviction thereof, the offending party or entity shall pay a fine of not less than \$100.00 per offense nor more than \$1,000.00 per violation and suffer any and all penalties as deemed necessary and appropriate by the court and in addition thereto, shall be subject to restitution and reimbursement of reasonable attorney's fees incurred by the Borough, to the Borough of Vandergrift, for all unpaid charges due Each day shall constitute a separate violation. This shall thereunder, if so ordered by the court. not preclude any other action, as provided under Pennsylvania law, for charges imposed under this Article may also be a lien on any property served from the date the charge first becomes due and payable. The Borough may also exercise all rights to municipal claims and collect any amounts due in a manner provided by law for the filing and collection of municipal claims and liens against the owner of property. All bills and charges shall be levied against the owner of property only who may retain ultimate responsibility for all liens and charges, as determined by the Street Committee, by policy.

Section 3 - \$404-6 - Precollection Practices:

The following provision shall be added to Section 404-6(A) – Preparation of Refuse:

(4) Any and all items, as deemed recyclable, by the Borough of Vandergrift, shall be placed in appropriate receptacles, to be placed at designated locations on the property, for the recyclable collection by the Borough of Vandergrift under and subject to any rules and regulations or code provisions enacted for the collection of recyclable materials.

Section 4 - §404-8 - Violations and Penalties:

The provisions of Section 404-8 – Violations and Penalties are hereby deleted in full and replaced with the following:

§404-8

Any person or entity, whether in their capacity as the owner, principal, agent or employee, who violates or, in any way, assists in the violation of any provision of this Article as associated with administration or collection of refuse or any regulation of the Street Committee enacted as a policy by the Council of the Borough of Vandergrift, shall be subject to citation and, upon a finding of

guilty and conviction, shall be sentenced to pay a fine of not less than \$200.00 nor more than \$1,000.00 per offense plus costs of prosecution and reasonable attorney's fees and in default of any payment of fine or costs, to undergo a term of imprisonment of not more than thirty (30) days. Each day shall constitute a separate offense and separate proceedings may be instituted and separate penalties imposed for each day's offense.

Section 5 – Repealer:

Any part or provision of any other Ordinance which conflicts with the provisions of this Ordinance shall be repealed to the extent that they conflict herewith.

Section 6 - Severability:

If any sentence, clause, section or part of this Ordinance is, for any reason, found to be unconstitutional, illegal or invalid, such unconstitutional, illegal or invalid part or portion shall be removed and shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared that it is the intent of the Borough of Vandergrift that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herewith.

Section 7 - Effective Date:

This Ordinance shall be effective immediately upon enactment.

ORDINANCE NO. 5 OF 2019

AN ORDINANCE OF THE BOROUGH OF VANDERGRIFT, COUNTY OF **PENNSYLVANIA** WESTMORELAND AND COMMONWEALTH OF JOINDER AND PARTICIPATION IN AN AUTHORIZING ITS INTERGOVERNMENTAL POLICE MUTUAL AID AGREEMENT WITH OTHER MUNICIPALITIES FOR THE TRAINING, DEPLOYMENT AND COMPENSATION OF SPECIALLY TRAINED OFFICERS (STO) FOR THE PURPOSE OF RESPONDING TO POLICE EMERGENCY SITUATIONS IN ANY AUTHORIZED JURISDICTION PROVIDED FOR IN THIS ORDINANCE AND PROPOSED INTERGOVERNMENT AGREEMENT. THE AGREEMENT FURTHER INCLUDES PROVISION FOR (1) DEPLOYMENT AND (STO) **OFFICERS** SPECIALLY TRAINED OPERATIONS TO BE CONDUCTED UNDER AN ESTABLISHED FOR JURISDICTIONAL PURPOSES, COMMAND UNIFIED IMPLEMENTATION OF THE STO PROGRAM, AS WELL AS (3) MISCELLANEOUS COMPLIANCE PROVISIONS, MINIMUM TRAINING, FINANCIAL RESPONSIBILITY FOR INDIVIDUAL AND JOINTLY OWNED EQUIPMENT, DEPLOYMENTS AND COMPENSATION, INCIDENT COMMAND, RECORDS, A LIMITED COLLECTIVE **PARTICIPATING** OF **EXPANSION** WAIVER, BARGAINING MUTUAL MUNICIPALITIES, WITHDRAWAL FROM THE AGREEMENT, AND INDEMNIFICATION PROVISIONS.

WHEREAS, all Municipalities are authorized by the laws of the Commonwealth of Pennsylvania to enter into a joint intergovernmental cooperation agreement for Mutual Police Aid and assistance; and

WHEREAS, the provision of Mutual Police Aid extending across Municipal boundaries promotes the health, safety and welfare of the citizens of the Municipalities; and

WHEREAS, the Borough of Vandergrift and several other Municipalities have determined a need exists for a Mutual Police Aid Agreement in Critical Emergency Response situations for Specially Training Police Officers (STO) in such situations; and

WHEREAS, these Municipalities, with support from the District Attorney of Westmoreland County, desire to provide well-trained Special Tactical Officers (STO) to respond to police emergency situations in jurisdictions where there exists a written Mutual Police Aid Agreement of participating Municipalities; and
