Dear Council of the Borough of Vandergrift:

The Kiski Valley Water Pollution Control Authority was directed by the regulatory agencies (Environmental Protection Agency and the Pennsylvania Department of Environmental Protection) in its National Pollution Discharge Elimination System permit (NPDES) to assume control of the following CSO outfalls in your community.

As you know, the regulatory agencies have now required that the sanitary and storm lines be separated and your community has been partially successful in doing that. As a result, the CSO outfall #018 located on Longfellow Street, which was closed on May 2, 2013 has been removed from our NPDES permit and we no longer have authority or responsibility for that outfall. The service agreement with the 13 member municipalities requires that the Kiski Valley Water Pollution Control Authority will have control only of the main connector lines which bring sanitary sewage to the plant located in Allegheny Township. Since your outfall #018 now simply delivers storm water directly to the Kiskiminetas River, the Kiski Valley Water Pollution Control Authority can no longer exercise any control or responsibility over them. The purpose of this letter and the enclosed acknowledgment allows us to update our records and confirm with the regulatory agencies that we no longer have responsibility for the outfall #018 in your community.



# SR 0056 Improvement Project - Section 22R Vandergrift Borough, Westmoreland County

#### Items of concern:

- The heavy rain and flash flooding which occurred on August 28, 2013 demonstrated the importance of having sufficient curb heights and water-carrying capacity on certain roadways. During heavy rains, water over-tops the existing 8" curb in the section from Jackson Avenue to Poplar Street. Council is concerned that raising the road and lowering the curb heights will reduce the water carrying capacity of the roadway allowing water to overflow the curbs more frequently, increasing the potential for to damage properties and structures.
- The latest plans that we have show a widening of the connecting lane between Lincoln & Custer near station 747+50. AT the public official meeting, there was mention that the crossover in front of the Casino would also be looked at for improved truck turning movement from Allegheny Ludlum. Has this been done and will the configuration be changed or improved?
- The is a section from approximately station 748 to 758 consists of existing asphalt pavement with stone curbs. The curb heights range from less than 2 inches to ±4 inches. Council is concerned that without full width milling, there will be little to no curbs left in this section.
- Allegheny Ludlum has expressed their concern regarding the need for more than one lane width for truck turning movements at their access drive and where trucks must turn to go East on SR 56.
- Allegheny Ludium has expressed their concern regarding the effect on curb heights and water flow along Lincoln Avenue.
- The Borough is concerned about being required to provide manhole adjustment rings to raise the manholes that will be affected. There are 31 manholes in the project area and most of them will need to be adjusted. The height and type of adjustment required may be different for each manhole. The frame and covers are old, of various sizes. Some are damaged or broken. Many of the frames are cast into the concrete. There may also be a gaps under the concrete which may need to be sealed. The Borough feels that the best results would be obtained if the manhole adjustments were part of the project. Since the Borough is not directing, controlling or constructing the project, the Borough will not have the ability to determine the appropriate height, size and type of adjustments required for each structure (see attached letter dated July 22, 2013).
- Under Custer Avenue near Sta. 744+50, a 36-inch concrete pipe enters a splitting chamber which directs the flow to the 36-inch concrete pipe (located near the center of the road) and also to a 15-inch cast iron pipe which flows into property of Allegheny Ludlum. The video of these lines show collapsed pipes, closed off catch basins and other problems which need to be checked before the roadway is improved. This is the area where the back-up and build-up of rain water begins. We need to access the splitting chamber to address these problems.
- Note that there is no parking on the south side of the highway between Farragut and Sumner Streets. We want to confirm that there will be no changes to, or limitation of parking on the North side of the highway at this location
